Introduction and Definitions

The following report will describe and summarize temporary and extended protection orders issued in the State of Nevada for the calendar year of 2006. These reports are broken down to show which orders were granted to men and to women. Also included is a listing of those orders that included custody of a minor child.

Definitions:

Temporary Protection Orders:

Can be granted within 24 hours of receiving the application and in effect up to 30 days or until scheduled court hearing.

Modified Temporary Protection Orders:

These are temporary protection orders that have been modified by the courts since their original issuing.

Extended Protection Orders:

Awarded only after a hearing before a judge and in effect for up to one year.

Modified Extended Protection Orders:

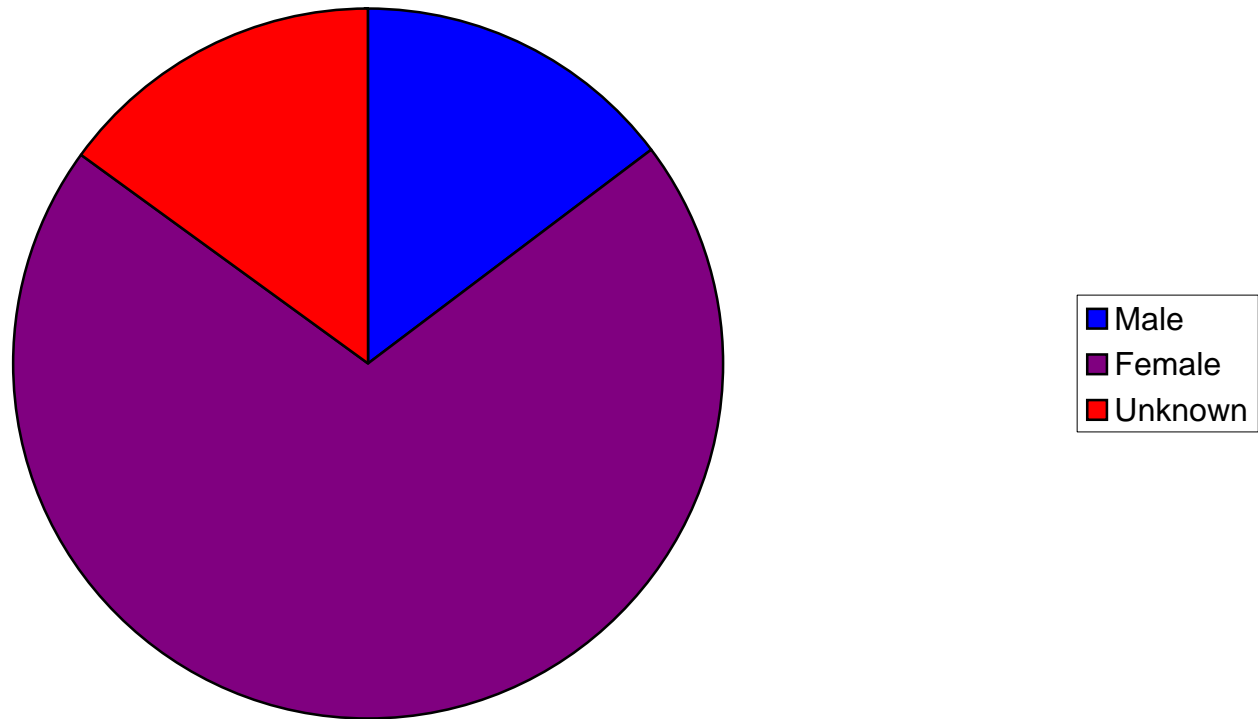
These are extended protection orders that have been modified by the courts since their original issuing.

Any of the above orders can also include a grant of temporary custody of a minor child.

Please note that on the graphs you will see gender described as male, female, and unknown. Unknown includes those who entered unknown on the application, or those that did not complete the gender portion of the application.

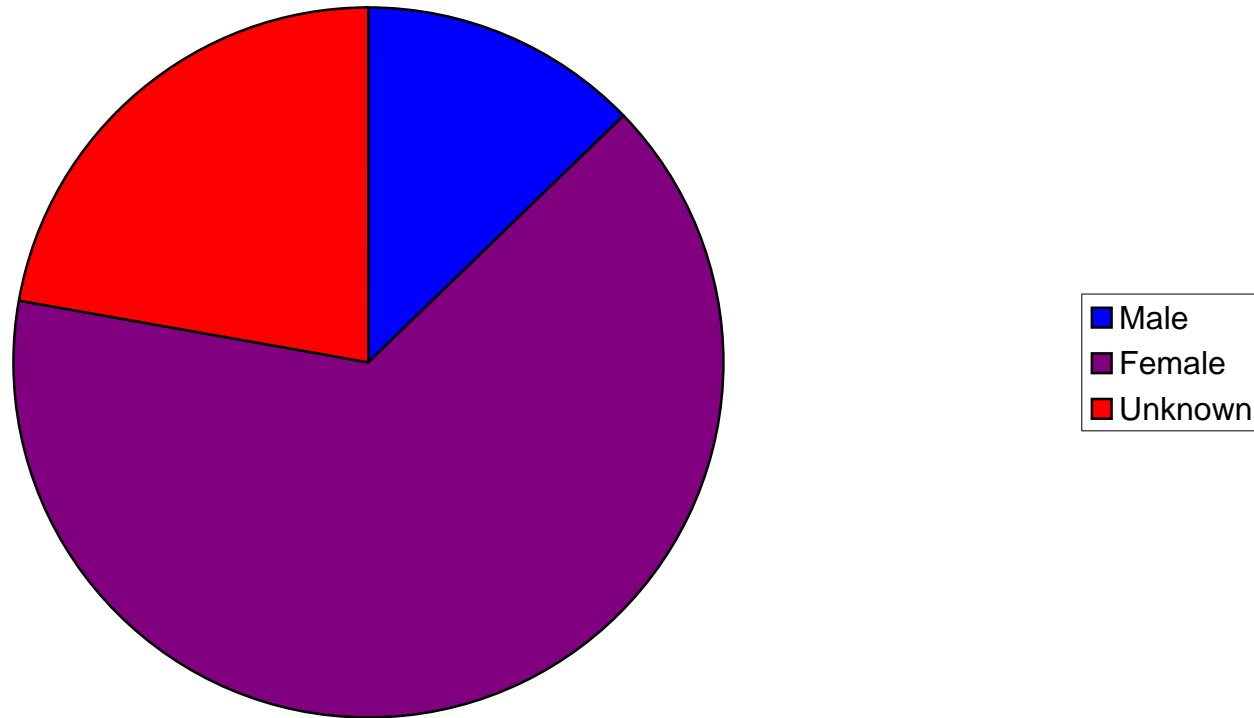

Between 1/1/06 and 12/31/06**



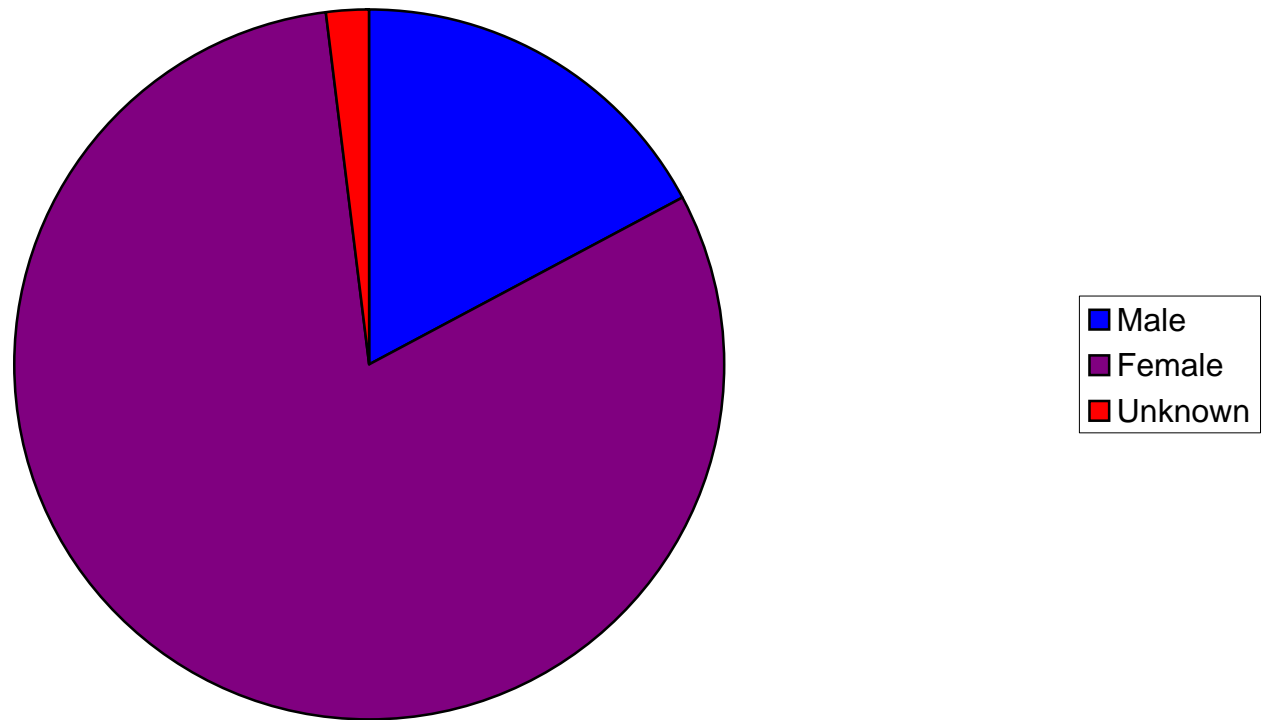

Between 1/1/06 and 12/31/06**



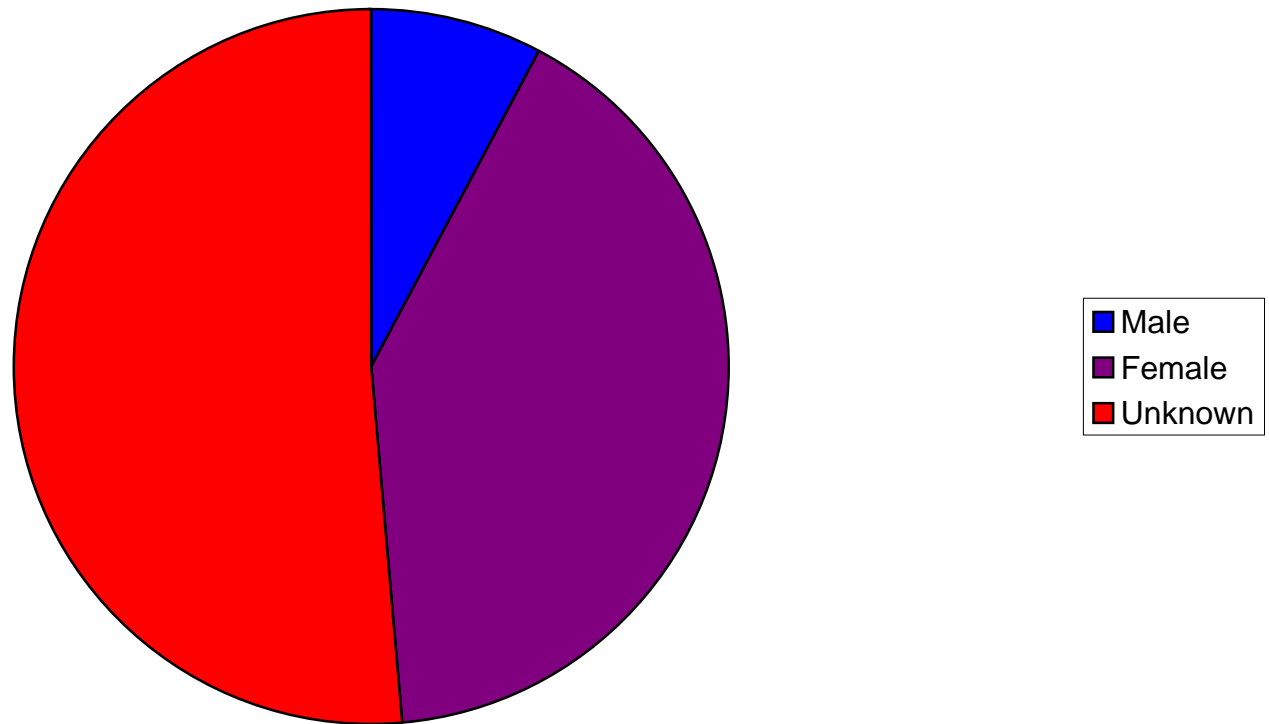

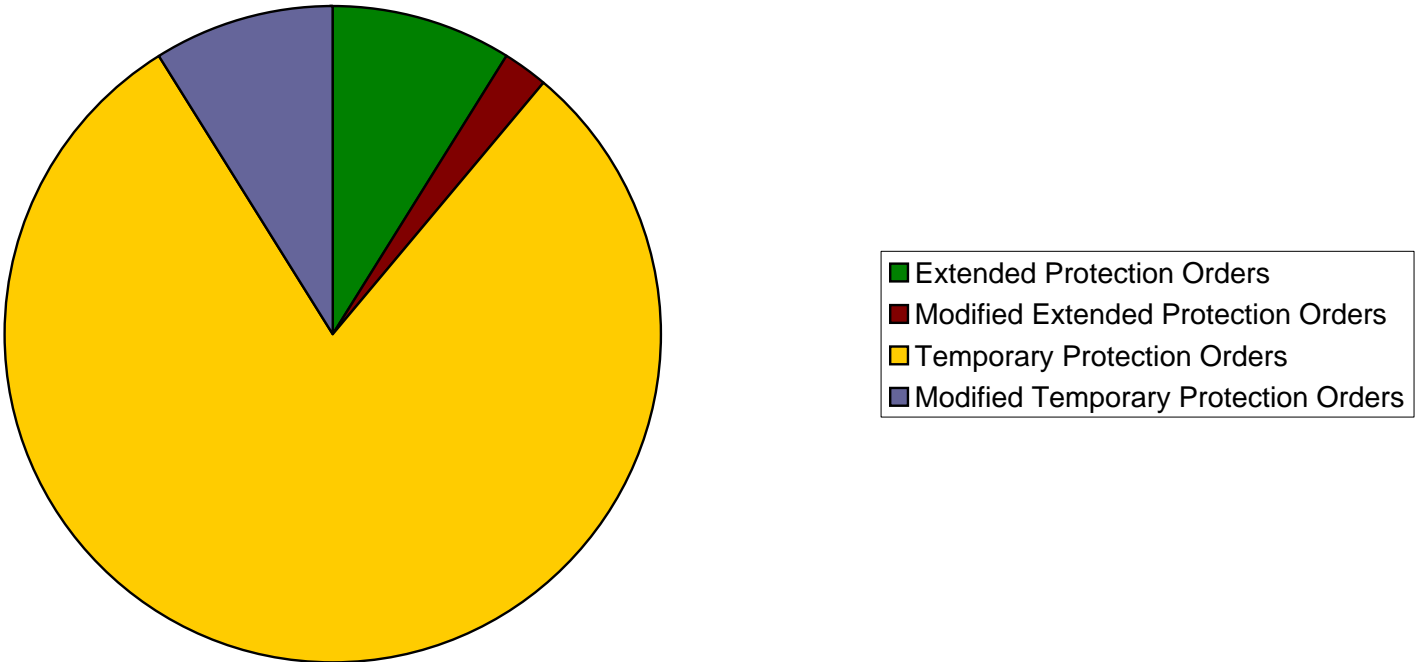

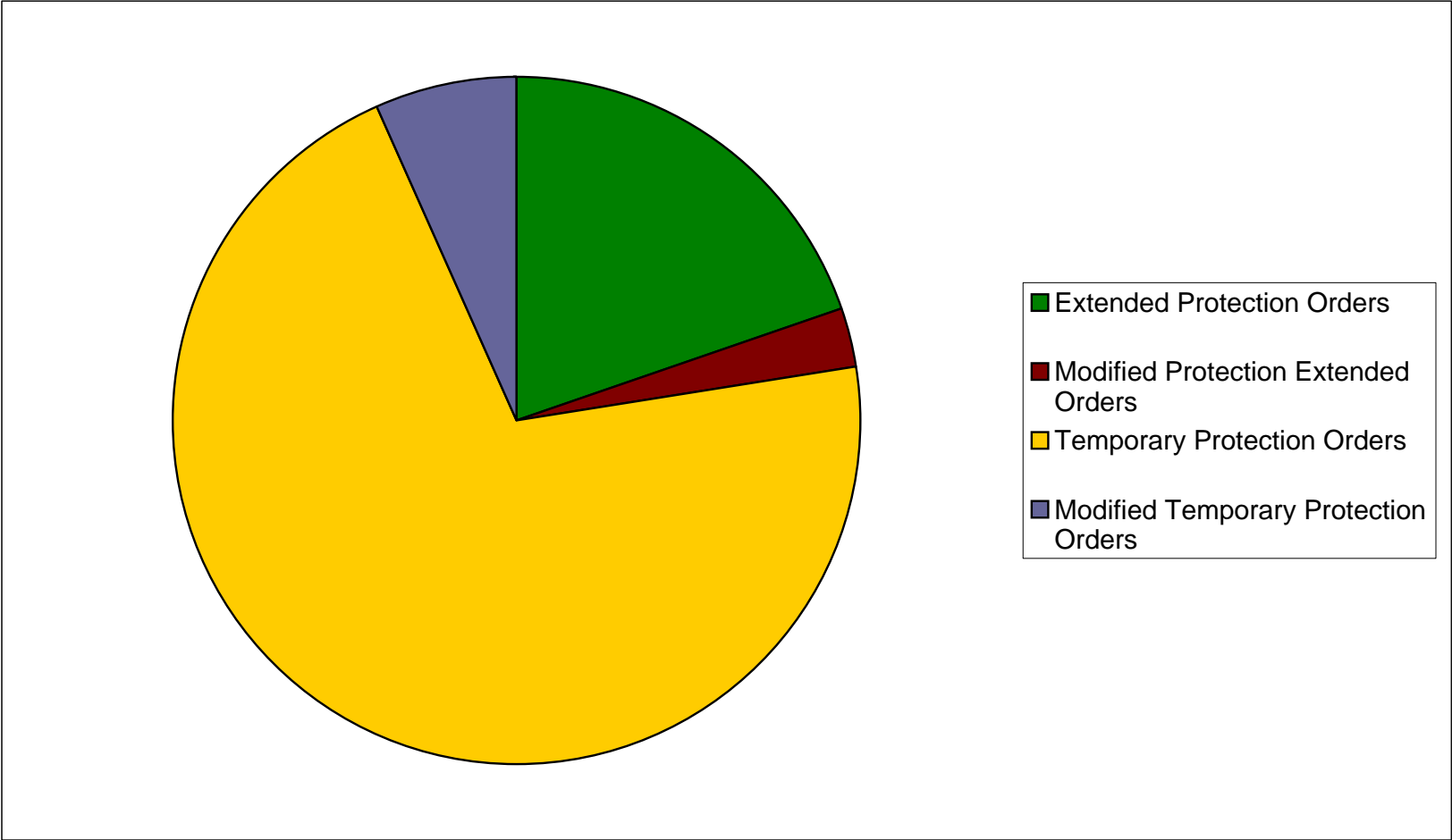
